In these T’s & C’s, we refer to the above promoter(s) as “the Landlord” and the entrants as “the Participant(s)” or “you”.

<b>3.</b>	<b><u>Eligibility:</u> Who may enter the Competition?”</b>	To enter the Competition a participant (“ <b>Participant</b> ”) must be <b>18 (Eighteen)</b> years or older and in possession of a valid South African identity document or passport.  No Minors are allowed to enter the Competition.
