In these T’s & C’s we refer to the above promoter(s) as “the Landlord” and the entrants as “the Participant(s)” or “you”.
<b>IMPORTANT INFORMATION</b>		
3.	<b><u>Eligibility:</u> Who may enter the Competition?”</b>	To enter the Competition, a Participant (“ <b>Participant</b> ”) must be: <ul style="list-style-type: none"> <li>i. 18 years or older and in possession of a valid South African identity document and/or South African passport and/or foreign national passport;</li> <li>ii. have access to the internet; and</li> <li>iii. have a Facebook account.</li> </ul>
4.	<b>Who cannot enter the Competition?</b>	The Competition may not be entered into by any director, member, partner, employee, agent, consultant, tenant of the Landlord at the Mall, the marketing service providers and/or any person who directly or indirectly controls or is controlled by these entities, including their spouses, life partners, business partners or immediate family members.
